

## **Grand Haven Host Lions Club Float Rental Agreement**

### **Requirements for use of Grand Haven Lions Club Float**

1. Towing vehicle must have insurance to cover what it is towing which must include the Float.
2. Towing vehicle cannot back Float up. This must be done by hand. This is imperative because of the design of the tongue on the Float.
3. Float must not be towed at faster than 40 miles per hour as Float trailer is not designed for this use. Towing faster than 40 miles per hour is done at your own risk.
4. All Float banners must be removed while Float is being towed.
5. Globe and Lion tie downs must be secured properly before transporting the Float.
6. Releaser may add to the Float anything it needs for their parade as long as it can be removed without damage to or permanent change in appearance of the Float. All items must be removed by Releaser before Float is returned.
7. Releaser must pay for any repairs or replacement items due to any loss or damages to the Float that occurs when the Float is in Releaser possession and must initial and sign this form accepting the Indemnification Agreement below.

### **Grand Haven Lions Host Club Indemnification Agreement**

In consideration of the acceptance by the Grand Haven Lions Host Club of your rental of our Float, the undersigned releaser releases and discharges the Grand Haven Lions Host Club, its officers and members, from any and all rights, claims, and actions which the releaser now has or may have for the signing of this release against the Grand Haven Lions Host Club, its officers and members, and its president arising out of this agreement or contract. This release is intended by the parties to release all claims for injuries, damages or losses to the releaser, and its property, real or personal, whether known, unknown, foreseen, unforeseen, patent or latent, which the releaser may have against renter. The releaser understands and acknowledges the significance and consequence of the specific intention to release all claims and assumes full responsibility, for any injuries, damages, or losses that it may have or may incur from performance of or in connection with this contract and agrees to hold harmless and indemnify the Grand Haven Host Lions Club from any and all claims, injuries and damages arising from or in connection with rental of the float, towing and transportation of the float, and participation in any or all parades the float is used in, or in any use of the float in connection with this agreement. The Grand Haven Host Lions Club damages include not only actual damages, but also reasonable attorney fees incurred by the Grand Haven Host Lions Club in defense of such claims, damages, or actions.

The following definitions apply through this release:

1. Releaser means releaser whether in the singular or plural, its officers, president, directors or if an individual, his or her spouse, family, heirs, personal representatives whether corporate or individual, administrators, successors and assigns.
2. Grand Haven Lions Host Club means The Grand Haven Lions Host Club a Michigan non-profit organization as well as its officers, president, directors, members, employees, agents and its successors and assigns.
